SURREY COUNTY COUNCIL.

Part IV.—Sections 32 and 38.

*Public Rights of Way.*

NOTICE is given that the Surrey County Council as surveying authority have, pursuant to the provisions of section 32 of the above Act, prepared a definitive map and statement indicating the public rights of way in the Administrative County of Surrey which are alleged to have subsisted on the 1st January, 1952.

The definitive map and statement may be inspected free of charge during office hours in Room 119 at the County Hall, Kingston-upon-Thames, Surrey. Appropriate extracts from the definitive map and statement have been supplied to each Borough, Urban and Rural District Council in the county and may be inspected by arrangement with the district authority.

An extract from the definitive map and statement relating to each Rural Parish in the county, has been supplied to the Clerk to the Parish Council with whom arrangements should be made to inspect the extract.

If any person desires to question the validity of the definitive map on the ground that the map is not within the powers of the above Act or on the ground that any requirement of this Act or of any regulation made thereunder has not been complied with in relation to the preparation of the map, or of any draft or provisional map on which that map is based, he may, within six weeks after the 29th August, 1958, make an application to the High Court.

*Survey of Rights of Way.*

NOTICE is hereby given that the County Council of the West Riding of Yorkshire in exercise of the powers conferred on them by sub-section (3) of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the draft rights of way map and statements prepared under section 27 of the above-mentioned Act in relation to the rights of

way within the areas of the Boroughs of Batley, Brighouse, Morley, Spensborough, and Todmorden, the Colne Valley, Denholme, Elland, Hebden Royd, Heckmondwike, Holmfirth, Kirkburton, Meltham, Mirfield, Ripponden, Saddleworth, Sowerby Bridge and Queensbury and Shelf Urban Districts, and of the Hepton Rural District by the deletion and addition of the public paths indicated in the schedule hereto and shown on a map which has been deposited at the office of the County Engineer and Surveyor at 93, Northgate, Wakefield, and which may be seen there until the 4th day of September, 1958, free of charge between the hours of 8.45 a.m. and 5.20 p.m. on each week-day (other than Saturday).

During the same period copies of the map so far as the same relate to each of the County Districts affected will be on deposit and may be inspected free of charge during normal office hours at the respective Council Offices except in the Rural District of Hepton where a copy of the map will be on deposit at the offices of the Cape Asbestos Company, Acre Mill, Old Town, Wadsworth, between the hours of 9 a.m. and 5 p.m. on each week day (other than Saturday).

Any representation or objection with respect to these determinations shall be made in writing addressed to the Clerk of the County Council, County Hall, Wakefield, before the 7th day of September, 1958, and shall state the grounds on which it is made.
